Thank you for your interest in the TIGER Afterschool Program. Please fill out this application form completely. There is a weekly fee of **\$30.00 (\$6.00 per day; on shorten weeks because of Early Release days and School Holidays the weekly fee will be adjusted)**. There are no daily rates or credit for missed days. The first Payment will be due prior to your child starting. **Weekly payments are due the Friday before the upcoming week.**

The East Helena School District Summer School and After School (Tiger) Programs are academic based enrichment programs funded through grants and tuition payments by parents. Please recognize that this is not a daycare service but an academic support program that extends students learning opportunities. Because this is an academic based program, the district has been directed by the IRS that it is unable to accept daycare flex funds and is not a tax deduction eligible expense for daycare assistance for families. The mission of this program is to assist eligible students with homework and build a more rounded experience with the STEAM areas of learning which include Science, Technology, Engineering, Arts and Math.
