- c. No person, other than the Board and the person having the floor, shall be permitted to enter into any discussion either directly or through a member of the Board, without the permission of the Presiding Officer.
- d. No questions shall be directed towards any individuals except through the Presiding Officer.
- e. Under Rules of Order, questions cannot be answered by the Board, only heard. The Board is not under any obligation to respond. It is illegal for the Board to take any action on the comments.
- f. Speakers will not mention specific names of individuals in a public forum due to rights of privacy. Individual attacks will NOT be tolerated.
- g. Comments made by the person addressing the Board do not represent the opinions of the Board, or staff and are only the expressed opinion of the speaker.

# **UNFINISHED BUSINESS**

1. Legislative Advocacy Update

**COMMENTARY:** The Board will have the opportunity to hear information about current bills and events relating to education at the Montana Legislature. Board Members will have the opportunity to ask questions and share opinions about the Legislative Agenda.

2. Budget Update and Mill Levy Consideration

SUPERINTENDENT'S RECOMMENDATION: Action Item. Recommend approving a mill levy request for the May Election.

3. Consideration of Logo Licensing Agreement with Safeway

The Committee also has presented a recommendation for purchase of instructional materials including lab kits and supplies.

3. Consideration of SMA Facilities Master Planning Proposal.

**COMMENTARY:** This proposal is a result of the LTIC work from last fall which recommended a deeper study of facility utilization and future needs projections. The proposal encompasses the work needed to make decisions as we manage growth within the District.

**SUPERINTENDENT'S RECOMMENDATION:** Action Item. Recommend Approval of the SMA Facilities Master Planning Proposal.

4. Review of McKinstry proposed Initial Facility Condition Assessment

**COMMENTARY:** The Design Build agreement approved at the Special Board meeting on February 27 will have several phases. This initial phase and scope of work will be a facility condition assessment to define the opportunities for improvement of our mechanical infrastructure that exist in the designated school buildings. McKinstry will coordinate this work with SMA to ensure there is no duplication of tasks between the two firms. The FCA is necessary to develop next steps.

**SUPERINTENDENT'S RECOMMENDATION:** Information Item.

Superintendent Out of State Travel Request - Competency Based (Personalized)
 Learning Training in Denver, Colorado - June 2023

**COMMENTARY:** Brian and I Would like to take a team of EHPS educators to this Competency Based Education training in Denver Colorado in June. The training is provided by Marzano Academies, one of the leading providers of such training in the US. Costs will be covered by Transformational Learning funds.

**SUPERINTENDENT'S RECOMMENDATION:** Action Item. Recommend Approving the Travel Request.

6. Disposal of Obsolete Equipment - Resolution #232

**COMMENTARY:** Nick Turner has requested that we dispose of the Bluebird bus parked at the East end of the bus barn. Mechanical issues with the bus have rendered it unworthy of daily route service.

**SUPERINTENDENT'S RECOMMENDATION:** Action Item. Recommend Approving the Resolution.

7. Notice of Intent Regarding Permissive Levies - Resolution #233

**COMMENTARY:** HB 307 requires us to disclose to taxpayers our initial intent regarding permissive levies for the upcoming school year. Kim and I have worked diligently to refine these numbers. Some are formulaic or are set to maximize a State match which will be explained in the meeting.

**SUPERINTENDENT'S RECOMMENDATION:** Action Item. Recommend Approving the Resolution as Presented.

8. FWP Hunter's Education Program Request

**COMMENTARY:** This is an annual requirement. Our students and families benefit from having Hunter's Ed classes taught locally in our schools. The course requires the use of demonstration firearms to teach safety.
